From registration day until August 1<sup>st</sup>, there will be a \$25.00 Service Charge.

**VOLUNTARY:** If a child chooses to drop from the program prior to August 1<sup>st</sup>, for Football / Cheerleading there will also be a \$50.00 deduction for your preordered uniform /equipment.

**MANDATORY:** If a child is dropped from the program for any of the following reasons, NO fees will be REFUNDED.

1. Failure to pay registration fees and raffle money ( if applicable ).
2. Failure to provide all documents required by deadline dates.
3. The child is a disciplinary problem.

## Grievance Policy

If any parent or participant has a concern or complaint the following procedure must be followed:

1. Talk to head coach
2. If the parent is not satisfied the Director of Football Operations should be contacted:
  - a. Football-Steve Kirin
  - b. Cheerleading-Sarah Stukas
3. If the parent is still not satisfied the appropriate President should be contacted:
  - a. DAA – Tony Lopez
4. If at this time the parent feels the concern still has not been corrected, the concern should be brought before the Executive Board for further investigation.
5. If at this point the parent is still not satisfied the league President will bring it to the Conference Board. At no time should any individual contact the Conference or National board.

## Consents and Legal Provisions

- DAA provides equipment/uniforms for all participants. The cost of the football equipment not returned is \$250.00; the cost of cheer uniforms not returned in is \$225.00.** Football participants will keep their personalized game jersey.

- Prior to being assigned to a team, receiving any equipment, or attending practices the following documents **MUST** be provided to DAA. Failure to provide these documents will result in a mandatory drop. **All documents MUST be received by the July deadline.**
  - Proof of age in the following form: Copy of certified Birth Certificate (NO hospital certificates).
  - Completed Medical Release signed by parent or guardian.
  - SPORTS PHYSICAL dated after January 1<sup>st</sup> of this year and before July of this year.
  - A copy of both sides of the report card issued in June of this year. All American form filled out with signatures
